## Submission Rules and Instructions

1. Fill in your name, address, phone number and email in the space provided. Please note, we are unable to ship to P.O. Boxes.
2. List a description for each ticket you are submitting with year of issue, event significance, signer (if applicable) and your declared value. For lines listing a quantity greater than one, enter the total declared value for all items in the "Declared Value" column.
3. Check the box to select **Ticket Grade** if you would like to have your ticket receive a numeric grade based on condition. If the box is left unchecked the ticket will only be labeled as authentic.
4. Check the box to select **Autograph Grade** (only applicable for autographed tickets) if you would like to have your authentic autograph receive a numeric grade based on condition.
5. Select the service level for your submission. Note, only one service level (signed or unsigned) can be selected per submission. If you would like to submit under multiple service levels, each submission must be submitted as a separate order with its own return shipping and insurance fees.
6. **Calculate the subtotal of fees.**
  - a. **Ticket Fee Calculation:** Based on the service level selected, multiply the total number of tickets by the appropriate fee.
  - b. **Re-Encapsulation Fee:** Items that have already been authenticated and graded by Beckett and now require a new holder due to scratching and/or chipping can be submitted for re-encapsulation for a fee of \$15. Note: if the sonic weld on the case has been broken, or shows signs of tampering, the item will not qualify for re-encapsulation and regular rates will apply.
  - c. **Insurance:** Insurance costs applies to all carriers and is based upon the declared value of the package

7. **Total Charges** and mark **Method of Payment**. All fees must be paid in advance before we can process your order. Your order will be charged upon receipt, returned checks will be assessed a \$30 fee. All payments must be in U.S. funds.

9. Place each item in a semi-rigid holder, we also recommend using "penny sleeves" in conjunction with the semi-rigid holders. Do not use screw down or hard acrylic holders. Beckett will not be responsible for any damages incurred by the use of improper holders. Items not submitted in individual sleeves will be charged \$0.50 per sleeve provided by Beckett.
10. Items must be accompanied by a Beckett ticket submission form. Failure to completely and accurately fill out the proper submission form may result in delayed turnaround times or additional charges.
11. **Ship Your Items to:** Beckett Authentication, 2700 Summit Ave, Ste 100 Plano, TX 75074. All items must be sent insured with a tracking number, we will not be responsible for uninsured packages.

Please note, tickets showing evidence of counterfeiting, tampering, or restoration will be charged the full amount according to the service option selected as the determination to reject an item requires review by Beckett graders and authenticators.

For any item for which either full payment or current contact information is not received within three (3) months from our receipt of the item ("Abandoned Item"), we will make a reasonable effort to contact you by email based on the contact information we have, but, if full payment and/or correct contact information is not received within such time, we will not be responsible for returning Abandoned Items. We can use, keep, destroy, discard, transfer, sell, donate, or give away Abandoned Items and retain any proceeds received from any disposition.
7. Re-Encapsulation service: By choosing to have an item re-encapsulated, you hereby release us from all liability for damage to the item due to our removing the item from the case. Alternatively, you retain the option to personally remove the item from the case in the presence of an authorized Beckett representative and resubmit it to us for service.
